Business Meeting

Meeting called to order by President Diane Mettler at 10:35 am.

Chairman Report:

Dogwood Park clean-up in October was not well attended. The weather was not helpful. Mary Bewley, Sherry Hanson, Linda Evaro, Kathleen Owen, and Mary Schactler, who is a neighbor to the park, put in a lot of work. An additional date was decided on to plant daffodil bulbs provided by Kathleen a few days later and again there were not many who were able to attend. Mary Bewley divided the bulbs into baggies and requested members present today take a small baggie and take to the park to plant at their leisure. It was also decided to plant part of the remaining bulbs in the flower barrels around the town of Eatonville. Diane pointed out the Park is showing its age. Plantings are overgrown, crowded and needing updating. Most of these plantings were put in around 1989. Such a large project is above our ability to take on on our own. Diane is investigating with the DOT as to what can be done to get some help with such a project. Nancy Schank has consented to act as an advisor to meet with DOT personnel if needed to discuss possibilities.
